<u>Directions from Houston</u> _I-45 North - Exit #164 Centerville Hwy 7 Go left over the freeway

Go right at the feeder road directly before Woody's/Shell gas station. Follow the feeder road for approximately 8 miles to the stop sign. At the stop sign go left (I will post signs along the way); you will be turning onto a ***<u>blacktop road that will become a white</u> <u>rock road after about a 1/3 of mile.</u>
